
# **Minor Research Project Grant Guideline**

#### 1. Introduction

Odisha State Open University provides financial assistance to teachers of universities, colleges and educational institutions in Odisha to carryout system-based research on Online Learning, Blended Learning and Open and Distance Learning (ODL) system and practices. The areas of research will cover, but not limited to:

- Distance/digital learning material development
- Online learning support
- Use of appropriate LMS platform including open source software in teaching/learning process
- Distance learning material development
- Learner support system
- Assessment and evaluation
- Application of technology in teaching and learning
- Tutoring and counseling
- Analyzing learners needs and preferences
- Challenges of people with disabilities and other disadvantaged groups

#### 2. Eligibility

The applicant must fulfill all the following criteria to be eligible for the Minor Research Project Grant provided by Odisha State Open University.

- A regular teaching faculty of a university / college / an institution recognized by the University Grants Commission (UGC) in any discipline or Academic Staff / Consultants engaged in Odisha State Open University.
- Having at least one published research article in a referred journal.
- A researcher can avail grant for only one project at any given point of time as the Principal Investigator.

#### 3. Nature of Assistance

The quantum of assistance would be up to Rs. 100,000.00 (one hundred thousand only). The assistance would be non-recurring (one time) and is categorised as minor research project grant.

This would include grant for the purchase of equipments, stationary, books, journals, software, print, publication, postage, internet, travel, field work, hiring of personnel etc. for the purpose and as per the requirements of the project. A budget outlining the expected expenditure should be included with the project proposal.

#### 4. Duration

The grant will be provided for a period of one year (twelve months) from the date of the issue of the approval letter. The Principal Investigator must submit the final report and comply with all the requirements within this period.

#### 5. Application Procedure

The eligible faculty may submit their Minor Research Project Proposal applications in the prescribed format as per the Minor Research Project Guidelines uploaded on the website of the university (<a href="www.osou.ac.in">www.osou.ac.in</a>) in the soft copy PDF form via mail at <a href="m.project@osou.ac.in">m.project@osou.ac.in</a> on or before 7th September 2020

Before submission, the concerned university should get the proposal assessed by their research committee with a certificate or a letter of endorsement from the competent authorities (Vice-Chancellor / Registrar / Dean / Director/Principal) of the university / college / institution that, the proposed research proposal is in conformity with the Minor Research Project guidelines. The scanned copy of the documents should be enclosed in the project proposal as per the prescribed format and send via mail <a href="mailto:m.project@osou.ac.in.">m.project@osou.ac.in.</a>

#### 6. Review and Approval Procedure

The received proposals duly forwarded by the competent authorities of the university / college / institution will be assessed with the help of an Expert Committee constituted by Odisha State Open University. The Principal Investigators may have to give presentation to the expert committee on the submitted proposals (no allowance will be provided by OSOU to make the presentation). The final decision will be taken on the basis of recommendations made by the Expert Committee and the availability of funds under the scheme.

The Principal Investigators and the competent authorities of the university / college /

institution of the selected proposals will be communicated within seven working days of the final recommendations of the Expert Committee. The details of the project grant initiation procedure will also be communicated. The Principal Investigators should send their acceptance certificate duly forwarded by the competent authorities of the university / college / institution immediately to the Registrar, Odisha State Open University. Upon receipt of the acceptance letter duly signed and forwarded by the competent authorities of the university / college / institution sanction letters will be issued.

#### 7. Copyright and Plagiarism

- The Principal Investigator will ensure that the final research report does not violate Copyrights / Intellectual Property Rights (IPR) of others and upholds academic integrity.
- Plagiarism is strictly prohibited as per the University Grants Commission (Promotion of Academic Integrity and Prevention of Plagiarism in Higher Educational Institutions) Regulations, 2018.
- The researcher(s) will retain the Copyright of the works coming out of the project. However, the researcher(s) agree to release the research reports and works coming out of

the project in Creative Commons Attribution-ShareAlike (CC BY-SA) license.

- Researcher(s) shall be encouraged to publish papers out of the project in open access journals. When a paper is published in subscription-based journals, a pre-print will be shared online at OER Repository of Odisha State Open University.
- The researcher/s will acknowledge the financial contribution of Odisha State Open University in all the publications coming out of the research project. And, submit copies to Odisha State Open University after publication.
- All accepted research reports shall be made available online in the OER Repository of Odisha State Open University under the Creative Commons Attribution-ShareAlike (CC BY-SA) license.

#### 8. Procedure for Release of Grants

The first instalment of the grant i.e. 40% of the sanctioned amount will be released after the Principal Investigator complies with the project grant initiation procedure. The grant will be released to the Principal Investigator; however, the competent authorities of the university / college / institution will be the custodian of the fund.

After receiving the half yearly progress report, statement of expenditure and utilization certificate of the 1<sup>st</sup> instalment of the grant; the second instalment i.e. 40% of the total grant will be released.

The third and the final instalment i.e. 20% of the remaining amount will be released only after receiving the following:

- Two hard copies of the final report along with the softcopy.
- A consolidated item wise detailed statement of expenditure incurred during the entire duration of project in the prescribed format duly signed and sealed by the competent authorities of the university / college / institution and the Principal Investigator.
- A consolidated Audited Utilization Certificate for the amount actually utilized towards the project duly signed and sealed by Govt. Internal Auditor / Chartered Accountant, competent authorities of the university / college / institution as well as the Principal Investigator in the prescribed format.

- The unutilized grant (if any) may be refunded immediately through demand draft drawn in favour of Odisha State Open University, payable at Sambalpur.
- The Principal Investigator through the University is expected to settle the accounts immediately on completion of the project.

#### 9. Transfer and Extension of Project

The project is not transferable. However, in case of transfer of the Principal Investigator from his / her original place of work to another institution / university the following process should be followed:

- A request letter for project transfer is to be submitted by the Principal Investigator.
- No Objection Certificate (NOC) should be furnished for the transfer of the project from both the institutions stating that necessary facilities will be provided by the Institution in which the awardee is transferred for the smooth functioning of the project.
- In case of any expenditure, an audited statement of accounts and utilization certificate is to be submitted by the Principal Investigator and should be forwarded by the competent authorities of the university / college /institution.
- In case of no expenditure, the whole amount is to be refunded back to Odisha State Open University.
- A fresh letter of affiliation (in the given format) from the competent authorities of the university / college / institution of the (new organization) is to be furnished.
- If the Principal Investigator fails to complete the project, he/she has to refund the entire amount released with interest rate applicable at the time of refund.
- No extension in tenure is permissible in any circumstances.
