## Technical Specification of the Server Space for Online Admission Portal

### 1. The proposed server must have the minimum of the following configuration:

- AWS Cloud;
- RAM: 32 GB;
- V CPU: 8 (2.4 GHz each),
- Space: 640 GB;
- OS: Cent OS 7
- Pre-installed software: PHP (7), My SQL(5.7), Apache (2.0)
- Data transfer: 3.5 TB;
- Control panel: C Panel WHM for a minimum of 5 accounts;
- AWS Cloud Hosting Location: Mumbai;
- SSL enabled

### 2. Technical Terms and Conditions:

- One dedicated IP must be provided.
- The Space shall be hired on monthly basis as and when required.
- The selected farm shall be responsible for the transfer and restoration of the old data to the new server.
- Daily back up should be kept by the firm and restore the data if required.
- The farm shall be responsible for the required changes in the configuration of the software (PHP & My SQL) on the server.

### 3. General Terms and Conditions:

- The bidder should be a registered company under the Indian Companies Act.
- The Agency should have a full-fledged development centre in Odisha.
- The bidder should have taken the assignment and successfully executed to provide AWS cloud server space for an online admission or similar application for any State/Central Government Universities continuously for two consecutive years.
