Sub: Regarding fund allotted under World Bank Assisted Program OHEPEE and signing of MOU

Madam/Sir,

I am glad to inform that your University has been selected under the World Bank funded program OHEPEE (Odisha Higher Education Program for Excellence and Equity) among the 11 universities which have submitted IDP proposals. As per the weightage given to various parameters (IDP - 40%, No of affiliated Colleges - 40%, No of Departments - 10%, No of regular students - 10%) the Universities are to receive the following amount in Crores

1. Utkal University, Bhubaneswar	:	38.74
2. Sambalpur University, Sambalpur	:	27.70
3. Berhampur University, Berhampur	:	23.29
4. Fakir Mohan University, Balasore	:	17.41
5. Ravenshaw University, Cuttack	:	17.87
6. Odisha Open University, Sambalpur	:	25.00 (Separate Criteria)

For the 1st year, the IDG amount to be released is 20% of your eligibility. Before such release, the 5 year work plan containing the various components of expenditure is to be agreed upon and signed along with the MOU. The items could be same or different to the ones mentioned in the IDP earlier.


Except Ravenshaw University and Odisha Open University, the Universities have to spend minimum 40% of the total IDG towards strengthening their affiliated Colleges through faculty training, improving NAAC accreditation, on time graduation, curriculum revision, exam reforms, online finance management systems etc.

The IDG amount includes the fund for setting up Centre of Excellence. The COEs to be taken up and the amount to be spent on them are to be worked out and intimated to the Department. A committee of experts under the Chairmanship of Vice-Chairperson, OSHEC will discuss with the Vice Chancellors to finalize the COE proposals and fund earmarked.

The list of Colleges selected for IDG under the program is enclosed as Annexure-I for supervision and development of these Colleges as Nodal Centres for faculty training and other quality and equity initiatives.

For effective environment management of the University premise a format is enclosed as Annexure-II. You are requested to submit the 5 year work plan, preliminary COE plan and environment format by 26th February, 2018 for further action.
