At the outset the Vice Chancellor Dr. Mohapatra initiated the discussion briefing the objectives of the OSOU. He highlighted the terms of reference of the Expert Committee constituted for the B.Ed Programme.

1.As regards the "Preparation of the Course curriculum of B.Ed" it was decided to take up the work as soon as the New Education Policy 2016 comes to light which is awaited. NCTE Regulation, 2014 and the existing State Syllabus for B.Ed, 2015

and the IGNOU B.Ed. Syllabus will be referred to while designing the course curriculum of the B.Ed of the OSOU.

2. With regard to the "Identification of the Course Writers for Design and Development of SIM, Preparation of audio/video lesson" the VC laid importance on developing these materials in both English and Odia.

After a thread bare discussion the Committee decided to develop the materials in Pedagogy of School Subjects(Methods of Teaching) in English and Odia. However, the rest of the materials be developed in English.

Due to paucity of time the course materials of other Universities may be borrowed for use till our materials are developed.

- 3. As regards the "Identification of Study Centres in NCTE recognized Teacher Education Institutions(TEIs)in the State"the following Govt. Colleges having Departments of Education are listed below keeping in view the distance, availability of RPs and Student Enrolment.

The names of nine colleges have been listed as Study Centres as above.

The VC is requested to identify one NCTE recognized College keeping in view the concentration of the Students and other criteria.

4.Regarding the "Preparation of general guidelines for Programme implementation, including support services, monitoring and supervision as per norms and standards stipulated in NCTE,2014"it was decided that- the existing NCTE and IGNOU guidelines for B.Ed Programme will be followed.

Monitoring and Supervision will be done by the members of Expert committee constituted by the OSOU.

The modus operandi of the B.Ed Programme will be as per IGNOU norms.
